# Waterford and Wexford Education and Training Board Minutes of Meeting held 10th September 2019 at 4.30p.m.

#### 100919.01 ELECTION OF CHAIRPERSON

The Chief Executive welcomed everyone to the meeting and invited nominations for the position of Chairperson and Deputy Chairperson of Waterford and Wexford Education and Training Board (Schedule (3)(1) of the Education and Training Boards Act 2013).

Cllr. Joe Kelly proposed that the position of Chairperson for this new five year term be rotated annually, i.e. a new Chairperson be elected each year; Seconded Cllr. Breda Brennan.

Cllr. Mary Farrell proposed that the position of Chairperson be for the full 5 year term to ensure consistency and continuity; Seconded by Mr. David Doyle. There being no further proposals both proposals were put to a Vote.

Cllr. Joe Kelly then proposed a secret vote and Cllr. Lola O'Sullivan proposed a 'show of hands' vote to decide on the rotation versus 5 year issue. The CE stated that as neither was a formal motion he requesting Board agreement to putting the first proposal of Cllr. Kelly for a secret vote to the Board on a 'show of hands'; Board members agreed with this. Cllr. Kelly's proposal was put to a 'show of hands' and was defeated 5 for and 13 against.

Following this a 'show of hands' for proposal that the Chairperson be appointed on rotation each year was taken; this proposal got 4 votes. The 'show of hands' for the proposal that the Chairperson be appointed for the 5-year period of the Board was taken. This proposal got 13 votes. One member abstained.

The Chief Executive (acting in his capacity as temporary Chairperson) declared that the proposal for the 5-year period was successful. The CE then invited nominations for the election of Chairperson.

Cllr. Barbara-Anne Murphy was nominated by Cllr. Garry Laffan and Seconded Cllr. Mary Farrell.

Cllr. Joe Kelly was nominated by Cllr. Breda Brennan and Seconded by Ms. Kate Miskella. The CE put both nominations to the Board and confirmed that the election would proceed to ballot.

Ballot Papers were distributed and Board Members were advised to mark an X beside the candidate of their choice and place in the ballot box. Cllr. Kathleen Codd Nolan and Cllr. Eddie Mulligan were nominated as tellers and members of the WWETB executive, led by the Director of OSD, oversaw the process. The votes were cast and counted. The CE thanked the Tellers and announced the result: 14 votes in favour of Cllr. Barbara-Anne Murphy and 4 in favour of Cllr. Joe Kelly. Cllr. Barbara-Anne Murphy was elected Chairperson for the 5 year term of the Board. Cllr. Murphy thanked her proposer and seconder and said she looked forward to a very positive five years for WWETB.

#### 100919.02 ELECTION OF DEPUTY CHAIRPERSON

Cllr. Barbara-Anne Murphy, Chairperson took the chair and invited nominations for the position of Deputy Chairperson. Cllr. Pat Nugent proposed Cllr. Lola O'Sullivan, Seconded Cllr. Kathleen Codd-Nolan. No further nominations were received and *Cllr. Lola O'Sullivan* was deemed elected. Cllr. Lola O'Sullivan thanked her proposer and seconder and wished Cllr. Barbara-Anne Murphy well in her role and was pleased to note Waterford and Wexford geographical balance in the appointments.

#### 100919.07 CE PRESENTATION: WWETB Strategy Statement 2018-2022.

The CE presented an initial promotional video showcasing an overview of the organisation to the Board and which included information on Waterford and Wexford Education and Training Board Strategy Statement 2018-2022. WWETB being a local statutory education and training authority, places Learning and the Learner at the heart of its education and training provision and the Strategy Statement sets out WWETB's vision, mission, core values and strategic goals and was drafted following a comprehensive consultation process. During the presentation the CE gave background to the development and implementation of the Strategy Statement and referred to the various sections. Collaborations and co-operation with other organisations and partnerships were highlighted including initiatives such as the 'In-Harmony' Concert at the National Opera House last year which featured students from WWETB post-primary schools and a performance by the staff choir.

Questions were invited and copies of the Strategic Statement were circulated to the Board. The Chairperson thanked the CE for his presentation and she highlighted the positive impact of ETBs on the community as WWETB continues to grow and provide for its wide geographical area.

#### 100919.08 Finance

- (a) Finance Report: The Finance Manager gave an overview of Waterford and Wexford Education and Training Board's current financial situation as set out in the Financial Summary included in the CE's Report circulated. The financial report presented Receipts and Payments for period 31st July 2019 and were largely on target; however it was noted that the Schools and Head Office 'Non-Pay' element is very tight as has been the case for a number of years. Questions from the Board were responded to including the operation of Department of Education and Skills and SOLAS funding.
- (b) Application to the Minister for Education and Skills for Overdraft facilities to the 31st December 2020. A proposal to borrow for the purposes of carrying out the Board's functions was presented to the Board for consideration and the Finance Manager explained the procedure (In accordance with CL 0066/2014 and Section 49 of the Education and Training Boards Act 2013). The Board accepted the proposal to seek the consent of the Minister for Education and Skills; Proposed Cllr. Pat Nugent; Seconded Cllr. Kathleen Codd-Nolan. The CE, for clarification advised the Board that the overdraft facility is historical and affects every ETB since 2013.

#### 100919.09 Correspondence

- (b) Nomination to Waterford Leader Partnership. Mr. Noel Hackett was nominated to the Board of Waterford Leader Partnership; Proposed Cllr. Pat Nugent; Seconded Cllr. Lola O'Sullivan.
- (c) Ministerial appointment of student representatives Mr. John Fortune and Ms. Paula Rochford to the Governing Body of Institute of Technology, Waterford as per Section 6 (4) (1)(e) of the Institutes of Technology Act 1992-2006 was noted by the Board and the term of office is for a period of one year from date of appointment.
- (d) Divestment and Licence Agreements regarding the patronage of Kilnamanagh Community National School received for signature.
- (e) Ministerial confirmation regarding the Transfer of Kilnamanagh National School from the patronage of the Bishop of Cashel, Ferns and Ossory Bishop Michael Burrows to that of Waterford and Wexford Education and Training Board and confirmation of amendment to patron register to reflect the transfer of patronage.
- (f) Correspondence from the Department of Education and Skills regarding the proposed transfer of patronage of Kilnamanagh National School and formal arrangements.
- (g) Transfer of Trusteeship: Gorey Community School. The CE outlined notice of withdrawal of the Irish Christian Brothers, one of the co-trustees of Gorey Community School and decision to transfer responsibilities and rights to the Loreto Sisters of Ireland, who are the other religious co-trustees of the school.
- (h) Department of Education and Skills sanction for lease in respect of Seapoint Industrial Park, Riverstown, Tramore in respect of YouthReach was outlined and CE explained the Lease process.
- (i) Correspondence from the Department of Education and Skills in respect of Committees of ETBs established under Sections 44 and 45 of the ETB Act 2013 with particular focus on Finance, Audit an Risk Committees and Boards of Management of Schools and other centres of education advising of term of office extension to 30th November 2019 in order to facilitate transition and to ensure continuity of governance and oversight during this period of changeover from the current Committees and Boards to the new Committees and Boards of ETBs.
- (j) Response from the Office of the Minister for Education and Skills re school places in the Gorey/North Wexford area. The response gave general details regarding planning for school provision and analysis of relevant demographic data and the minister highlighted that the requirement for new schools will be kept under ongoing review. The CE added that further meetings to take place with DES.

- (k) Update regarding classification of ETB schools (non-designated) Community Colleges that the patron register is updated to change the term inter-denominational to multi-denominational.
- (I) Correspondence from the President of ETBs National Parents Association offering support in relation to the establishment of a Parent Forum in each ETB was welcomed.

#### 100919.10 Governance

  The Board were in agreement with the dates as outlined and the next meeting to take place 12<sup>th</sup> November 2019 at 4.30p.m. in Waterford Training Centre. It was agreed to circulate a schedule of dates to the Board.
- (d) Annual Report 2018: The Annual Report 2018 was circulated to the Board and the Director of OSD gave an overview of the Report and confirmed that a Draft 2018 Annual Report was submitted to the Department of Education and Skills at the end of June. The Annual Report 2018 was adopted by the Board; Proposed Cllr. Kathleen Codd-Nolan; Seconded Cllr. Lola O'Sullivan.
- (e) Process around Nominations from the Board to Boards of Management and other Committees.

  Two documents were distributed to the Board consisting of (1) a List of current membership of Committees and Boards and (2) a list of WWETB Membership of Schools' Boards of Management.

  A possible process for the selection of nominees was suggested by the CE and included the setting up of a Sub-Group to examine preferences from Board members and submission of a draft proposal to the Board at the next meeting.

Following discussion the Board agreed to the setting up of a Sub-Group to examine a process around nominations to Boards and Committees; Proposed Cllr. Mary Farrell, Seconded Cllr. Pat Nugent. The following Volunteers were agreed: Cllrs. Lola O'Sullivan, Pat Nugent, Mary Farrell and Chairperson Cllr. Barbara-Anne Murphy. The Sub-Group agreed to sit and report back to the Board.

The CE briefed the Board on general membership and make-up of the various boards and committees including statutory Audit and Risk and Finance Committees. Committees Terms of Reference are set out in the Code of Practice for the Governance of Education and Training Boards. Membership of the Audit and Finance Committee can involve advertising for members with appropriate expertise to ensure an overall range of skills for the Committee as a whole. Mr. David Doyle recommended training for Committee Members. Cllr. Pat Nugent complimented the

Finance Manager for his assistance as and when requested by the Finance Committee. Cllr. Pat Nugent urged geographical balance where possible and proposed advertising for Expressions of Interest from persons willing to serve as External Members on Audit and Risk and Finance Committees; Seconded Mr. David Doyle.

Area Committees: A brief summary of Area Committees, which were set up by WWETB to discuss the issues affecting education, training and youth development activities within local areas of Waterford City and Tramore, West and Mid Waterford, South Wexford and North Wexford, was provided. Currently four Area Committees operate and it was suggested that the number be reduced to three to recognise the lack of Board members from West and mid Waterford area. The Board agreed to three Area Committees for the period of this Board i.e. Waterford City and County, South Wexford and North Wexford. Proposed Cllr. Pat Nugent; Seconded Cllr. Mary Farrell. Cllr. Mary Farrell found the facilitation of Area Committee meetings most beneficial.

Section 29s: Former Board and VEC Members and extra nominees such as retired Principals were eligible to be nominated to Section 29 Committees along with current Board members. It was agreed that this practice would continue.

(f) Standing Orders Waterford and Wexford ETB: The Director of OSD outlined the background to the Standing Orders, which were circulated to the Board. The newly drafted Standing Orders provide additional information and sections to the document following the newly issued Code of Practice for the Governance of Education and Training Boards. Some advances include publishing of minutes and Declaration of Interest - Conflict of Interest forms. The Board approved minor change to Section 3.2 whereby bi-monthly meetings are held on the second Tuesday generally. The Standing Orders of WWETB were adopted: Proposed Cllr. Mary Farrell; Seconded Cllr. Kathleen Codd-Nolan.
