#### 250325.06 PRESENTATION - MICHELLE KEATING - YOUTHREACH CO-ORDINATOR

Michelle Keating Youthreach Co-ordinator gave a presentation to the Board during which she provided an overview of the services provided in the Youthreach centre in New Ross. Included in the services offered by the centre is Special Education Needs (SEN) Mentoring programme. Four staff operate as mentors for this programme. The programme offers the learners 1:1 mentoring.

Information was requested on the number of children undertaking the junior and leaving certificate who are members of the Travelling community. Eimear Ryan, Director of schools said that she

would establish what data was available and revert regarding this matter.

Following further questions, the Chairperson and Board joined in thanking Ms Keating for her presentation and acknowledged the excellent work being done by her and her team.

#### 250325.07 FINANCE

(a) Draft Annual Financial Statements (including statement of internal control) and associated documentation 2024.

A copy of the draft financial statements for the year ended 31st December 2024, draft letter of representation and draft financial statements confirmation by the Chief Executive were circulated to the board in advance of the meeting.

Ms. Jenny Dempsey, AO, Finance Department gave a presentation to the board on the WWETB Annual Accounts 2024 consisting of an overview of the financial statements, approval timeline, financial summary of receipts, payments, key points and a comparison to 2023 and the budgeted Service Plan. She outlined the steps of the approval process and recommendations from: the Audit and Risk Committee on the Statement of Internal Control (SIC) 12th February 2025, the Finance Committee on the Financial Statements 18th March 2025 prior to presentation to the Board and, if approved submitted to the Comptroller & Auditor General (C & AG) by the statutory deadline of 1st April.

The Receipts were broken down under Schools & Head Office, Further Education and Training, Youth Services, Agencies & Self-Financing, Capital Projects and the opening cash balance at January 1st, 2024 was  $\in$ 17.4m. The presentation included a breakdown of the 2024 Payments under the same headings with a closing cash balance as December 31st, 2024, of  $\in$ 11.6m – driven by surplus expenditure in relation to Solas allocation and finalizing capital projects.

Fluctuations in the Financial Summary 2023-V-2024 and Service Plan comparison were explained and related mainly to Solas expenditure items.

The board adopted the WWETB Financial Statements for the year ended 31st December 2024 and the Statement of Internal Control (SIC) including signature of the relevant accompanying statements by the Chairperson and Chief Executive including the SIC, Letter of Representation and Financial Statement Certificate of the Chief Executive:

- (b) **Approval/ Renewal of Leases:** Youthreach Waterford; on foot of a 5-year review of lease the base line rental was increased by 20% (broadly in line with the CPI increase in the intervening period 22%) as per the terms of the original agreement signed in 2018.

Wexford Further Education and Training Centre Whitemills Building; to facilitate the obtaining of Departmental approval and to allow works to be carried out over the Summer, if required, approval in principle was given for the development of an additional 184 sqm at this location.

This would allow for a fit out in the attic area which would provide an additional 3 classrooms, an office and toilets. If the development proceeds, the cost of the fit out will be added to the existing rent.
