111125.05 MINUTES

The minutes of the Waterford and Wexford Education and Training Board (WWETB) meeting held on 9th September 2025 were adopted.

Proposed Ms. Kate Miskella; **Seconded** Cllr. Blaise Hannigan.

Under *Matters Arising* Mr. Michael O'Brien reverted to the query from Cllr Michael Sheehan from September's board meeting, regarding capacity at Wexford Youthreach. Mr. O'Brien raised this matter with Ms. Susan Sheehan, Adult Education Officer, who confirmed she is satisfied that the current space is adequate.

111125.06 FINANCE

(a) Finance Update

Mr. Cathal Cremer provided a financial update to the Board and advised that WWETB's 2025 spend will continue to be monitored closely to year end and is on track to spend the 2025 allocation. He advised that the Finance Team have met with the Area Training Manager regarding the apprenticeship budget and contracted training. He also confirmed that the Finance team in conjunction with the SMT will shortly begin the process of preparing the 2026 SOLAS budget, however, it is unclear at this point whether SOLAS want WWETB to formally submit a bid. Clarification is being sought from SOLAS on this point.

In relation to schools and the mainstream budget, Mr. Cremer advised that the recent announcement by Energia of a 12.1% rise in electricity prices will not apply to schools. WWETB's main scheme pay has been tracking 5% higher than the start-of-year service plan, however, this has been the case for the last number of years. Much of this is driven by pay costs which are not deemed problematic as all posts are sanctioned by the Department of Education and Youth and are within WWETBs sanctioned staff allocation.

Cllr Blaise Hannigan queried how much of the €79M funded for apprenticeships was given to WWETB. Mr. Cremer confirmed this was just over €5M.

Mr. Michael O'Brien advised that a full financial report is included in the Chief Executives report.

(b) Multi Annual Procurement Plan

Mr. Alan Quirke gave an overview of WWETB's multi annual procurement plan (MAPP) and explained that the MAPP is an in-depth spend analysis which will assist WWETB in developing a strategic category of purchases management and an overall organisational approach to procurement.

(c) Corporate Procurement Plan

Mr. Alan Quirke provided an update on WWETBs Corporate Procurement Plan 2025 and advised that the plan sets out the aims and objectives for improving on an incremental basis, procurement outcomes for the organisation. The aim of the plan and MAPP is to ensure money is spent efficiently and effectively.

111125.07 PRESENTATION

Mr. Alan Quirke gave a presentation on Strategy Implementation and advised the Board that the Education and Training Board Act 2013 requires WWETB to review how its strategy is being implemented. Highlighting the 6 key strategic objectives, he provided an overview of the strategy statement 2023-2027, outlining progress during 2025 as well as priorities for 2026. A series of ongoing initiatives including a new e-recruit system, applications for funding to meet climate challenges, health and awareness and digital learning were some of the key highlights. Mr. Quirke said that while there are resource challenges, it is important to use the resources we have as effectively as possible. The next strategy will cover the period 2028-3032.

Dr Karina Daly advised the Board that this would be Mr. Quirke's final meeting as Director of OSD as he moves on to Wexford County Council as Director of Services and thanked him for his immense contribution around strategy, planning and development.

111125.09 GOVERNANCE

(a) Risk Management:

Mr. Michael O'Brien, Director of OSD provided the Board with an overview of the risk report as circulated. He noted that five new risks have been added to the register. He informed the Board that work is ongoing in development of a new risk register covering the area of ISMS. This will be presented at the next Board meeting.

Ms. Kate Miskella, member of the Audit and Risk Committee (ARC), provided an update on proceedings at its meeting of 01st October 2025. Ms. Miskella advised that the committee had discussed the Baseline Standards audit report, which included 55 recommendations. The Information Security Management Systems (ISMS) Team is currently addressing recommendations in the report. She said challenges around ICT expertise were also discussed. The Director of Internal Audit has been invited to the next committee meeting scheduled to take place on the 26th of November 2025.

Cllr Lola O'Sullivan (Chair) advised that representatives of the ARC and Finance committees would be invited to provide a short update of proceedings at future board meetings.

Mr. Michael O'Brien, Director, OSD updated Board members on the results of the Boards annual evaluation of its own performance. Eleven members completed the evaluation. Overall, the findings were positive. He thanked everyone who took the time to complete the evaluation and invited any member who had concerns to contact him directly.

(f) Charity Compliance Form

Mr. Michael O'Brien, Director, OSD advised members that under the Charities Governance Code, all registered charities are required to complete a Charities Governance Code compliance record form annually. Accordingly, as a registered charity WWETB had completed a compliance form. The document as circulated was reviewed by the Board and noted.

(g) Report from ETBI members forum

Cllr Lola O'Sullivan updated members on the recent ETBI members forum meeting which she attended. The ETBI Conference, which took place on the 9th October at the Slieve Russell hotel, Co. Cavan, was discussed. She advised that feedback following the conference suggested a one-day event was the preferred option; however, the latter part of the agenda was rushed. A meeting took place with Minister McEntee, and there were discussions on the payment of fees for participating on interview boards. This has gone back to DPER for consideration. SOLAS talked extensively on funding allocations and the issues that arose during the year.

(h) Standard in Public Office – Annual Returns

Mr. Michael O'Brien, Director of OSD advised Board members that the return of standards in public office declaration forms are required annually. A form will be sent to all board members prior to the January meeting. He stressed the importance of completing the form, even if there is a nil return. Further information will be provided at the January meeting

(i) Process for seeking external professional advice

Mr. Michael O'Brien, Director, OSD brought to the attention of Board Members the requirement of the code of practice for the Governance of ETB the requirement that; the Board should, in a Board resolution, lay down formal procedures whereby Board members, in the furtherance of their

duties, may take independent professional advice. The proposed procedures as circulated were agreed. The Board also agreed that the existing approach to recording the minutes of meetings was adequate for recording the concerns of Board members that cannot be resolved.

(j) Climate Action Roadmap

Mr. Alan Quirke, Director, OSD updated members on the Climate Action Roadmap 2025 which sets out WWETB's overall mandate and climate targets, in areas such as buildings, green procurement transport and use of fossil fuels. Mr. Quirke confirmed that the document has been reviewed and approved by the Senior Management Team.

Cllr. John O'Leary queried the possible use of solar panels on WWETB buildings. Mr. Fintan O'Reilly, Corporate Services Manager advised that solar panels are currently installed on 12 schools, but a review of more industrial type installations, especially on FET buildings is underway.
